- b. It was agreed that the winning bidder will replace any items included in Lot 1 that are about to expire in six (6) – month time if the concerned item has less than three (3) years of expiration on the time of delivery.

- c. It was noted that the brand of Glucometer Strips to be delivered must be the same with the brand of the machine - Blood Glucose Monitoring System. Also, it was made clear, that the Glucometer Strips is included in Lot 1 and not in Lot 2.
- d. It was also reiterated that all items (both for Lot 1 and 2) are to be delivered in the main campus, PhilSCA – VAB, Piccio Garden, Villamor, Pasay City.
- e. It was also mentioned that the bidders need to accomplish its Price Schedule in indicating the unit price of each item reflected in every lot.
- f. Bidders are requested to submit also a *flashdrive* containing the scanned copies of their eligibility/technical documents as reflected also in the checklist presented in the Bidding Document.

This Supplemental Bid Bulletin No. 1 shall form part of the Bid Documents. Any provision in the Bid Documents inconsistent herewith is hereby amended, modified, and superseded accordingly.
