INVITATION TO BID FOR THE

1. The **Philippine State College of Aeronautics**, through the **Corporate Budget for the contract approved by the governing Boards** intends to apply the sum of **Ten Million Three Hundred Thousand Pesos (P 10,300,000.00)** being the total ABC to payments under the contract for the **Supply and Delivery of Training Needs for Capacity and Resiliency through Upskilling: Democratizing Aviation Education Demography Approach Initiative of the Philippine State College of Aeronautics (PhilSCA)/PB2024-G-21** for the following lots:

Bids received in excess of the ABC shall be automatically rejected at bid opening.

2. The Philippine State College of Aeronautics now invites bids for the above Procurement Project. **For Lot 1, Delivery of the Goods is required for five (5) days** (see the TOR for the specific dates) **and for Lot 2, delivery of goods is required for fifty six (56) days** (see the TOR for the specific dates) **upon receipt of Notice to Proceed**. Bidders should have completed, within two (2) years from the date of submission and receipt of bids, a contract similar to the Project. The description of an eligible bidder is contained in the Bidding Documents, particularly, in Section II (Instructions to Bidders).
3. Bidding will be conducted through open competitive bidding procedures using a non-discretionary “*pass/fail*” criterion as specified in the 2016 revised Implementing Rules and Regulations (IRR) of Republic Act (RA) No. 9184.
- a. Bidding is restricted to Filipino citizens/sole proprietorships, partnerships, or organizations with at least sixty percent (60%) interest or outstanding capital stock belonging to citizens of the Philippines, and to citizens or organizations of a country the laws or regulations of which grant similar rights or privileges to Filipino citizens, pursuant to RA No. 5183.
4. Prospective Bidders may obtain further information from **Philippine State College of Aeronautics** and inspect the Bidding Documents at the address given below during 8:00 AM to 5:00 PM.

A complete set of Bidding Documents may be acquired by interested Bidders on September 15, 2024 from the given address and website(s) below and upon payment of the applicable fee for the Bidding Documents, pursuant to the latest Guidelines issued by the GPPB, in the amount of **Eight Thousand Five Hundred Pesos, PhP 8,500.00** for lot-1, and **One Thousand Eight Hundred Pesos, PhP 1,800.00** for lot-2, the amount of **Ten Thousand Pesos, PhP 10,000.00** if the bidder will bid for the two lots. The Procuring Entity shall allow the bidder to present its proof of payment for the fees in person.
6. The Philippine State College of Aeronautics will hold a Pre-Bid Conference¹ on **September 23, 2024 at 9:00 AM** at the **PhilSCA Multi-Purpose Hall**, Ground Floor of Building – B, PhilSCA, Piccio Garden, Villamor, Pasay City which shall be open to prospective bidders.
7. Bids must be duly received by the BAC Secretariat through manual submission at the office address indicated below on or before **12:30 PM on October 7, 2024**. Online or electronic submission of bids is not permitted. Late bids shall not be accepted.
8. All Bids must be accompanied by a bid security in any of the acceptable forms and in the amount stated in **ITB Clause 14**.
9. Bid opening shall be on **October 7, 2024 at 1:00 PM** at the given address below. Bids will be opened in the presence of the bidders' representatives who choose to attend the activity.
10. The *Philippine State College of Aeronautics* reserves the right to reject any and all bids, declare a failure of bidding, or not award the contract at any time prior to contract award in accordance with Sections 35.6 and 41 of the 2016 revised IRR of RA No. 9184, without thereby incurring any liability to the affected bidder or bidders.
