This Supplemental Bid Bulletin No. 1 dated November 13, 2024 is being issued to clarify, modify or amend items in the Bidding Documents.

The following items in the Bidding Documents for the Rebidding for the Procurement of Various Medicines, Medical Supplies, Tools and Equipment for PhilSCA Campuses as discussed and agreed during the pre-bid conference held last November 7, 2024 are hereby revised/amended:

to expire in six (6) – month time if the concerned item has less than three expiration on the time of delivery.

- 2. The following were the discussions during the prebid conference:
- a. It was reiterated that the project is divided into two (2) lots.



- b. It was agreed that the winning bidder will replace any items included in Lot 1 that are about to expire in six (6) month time if the concerned item has less than three (3) years of expiration on the time of delivery.
- c. It was noted that the brand of Glucometer Strips to be delivered must be the same with the brand of the machine Blood Glucose Monitoring System.
- d. It was also reiterated that all items (both for Lot 1 and 2) are to be delivered in the main campus, PhilSCA VAB, Piccio Garden, Villamor, Pasay City.
- e. It was also mentioned that the bidders need to accomplished its Price Schedule in indicating the unit price of each item reflected in every lot.
- f. Bidders are requested to submit also a *flashdrive* containing the scanned copies of their eligibility/technical documents as reflected also in the checklist presented in the Bidding Document.

This Supplemental Bid Bulletin No. 1 shall form part of the Bid Documents. Any provision in the Bid Documents inconsistent herewith is hereby amended, modified, and superseded accordingly.
