RESOLUTION OF THE PHILSCA BIDS AND AWARDS COMMITTEE RECOMMENDING TO AWARD THE CONTRACT FOR THE REBIDDING OF THE PROCUREMENT OF VARIOUS MEDICINES, MEDICAL SUPPLIES, TOOLS AND EQUIPMENT FOR PHILSCA CAMPUSES TO DOCA PHARMA AND MEDICAL SUPPLIES TRADING WITH A CONTRACT PRICE EQUIVALENT TO SIX HUNDRED FIFTY SEVEN THOUSAND THREE HUNDRED SIXTY THREE PESOS (P 657,363.00) FOR LOT-1 AND SIX HUNDRED FIFTY THREE THOUSAND SEVEN HUNDRED NINETY ONE PESOS (P 653,791,00) FOR LOT-2 AND RECOMMENDING THE APPROVAL FOR THE FOREGOING FINDINGS OF THE BIDDING ACTIVITIES

WHEREAS, BAC Resolution No. 207A - 2024, was approved and declared DOCA Pharma and Medical Supplies Trading as the winning bidder with Single Calculated and Responsive Bid for the Rebidding of the Procurement of Various Medicines, Medical Supplies, Tools and Equipment for PhilSCA Campuses with a contract price equivalent to Six Hundred Fifty Seven Thousand Three Hundred Sixty Three Pesos (P 657,363.00) for Lot-1 and Six Hundred Fifty Three Thousand Seven Hundred Ninety One Pesos (P 653,791.00) only;
