This Supplemental Bid Bulletin No. 1 dated March 10, 2025 is being issued to clarify, modify or amend items in the Bidding Documents.

The following items in the Bidding Documents for the Outsourcing of Flight Training Services of Thirty-Eight (38) BSAT Students for Multi-Engine and Instrument Rating as discussed and agreed during the pre-bid conference held last February 26, 2025 are hereby revised/amended:

## 1. Invitation to Bid

Bids received in excess of the ABC shall be automatically rejected at bid opening.

The Philippine State College of Aeronautics, through the **Corporate Budget for the contract** approved by the governing **Boards** intends to apply the sum of **Twenty-Three Million One Hundred Forty-Two Thousand** Pesos (PhP 23,142,000.00) being the ABC to payments under the contract for the Outsourcing of Flight Training Services of Thirty-Eight (38) BSAT Students for **Multi-Engine and Instrument** Rating/PB2025-Goods and Services-1. Bids received in excess of the ABC shall be automatically rejected at bid opening.

Instructions to Bidders (ITB) Clause 10 marked "TECHNICAL COMPONENT", and their financial documents described in ITB Clause 11 in another sealed "FINANCIAL envelope marked COMPONENT", sealing them all in an outer envelope marked "BID". All pages of the original and duplicate copies must be properly signed (wet signature) by the bidder's authorized representative.

Bidders are made to understand the documents they need to submit as discussed in the provided checklist. It was mentioned that Section VI (Schedule of Requirements) and Section VII. (Technical Specifications) of the Bidding Documents must be signed by the bidder's authorized representative and both must be included in the first envelope.

The BAC instructed the bidder to submit one original copy and three (3) photocopies of the documents contained in envelope 1 and 2. It was also mentioned that the BAC will recommend to the College President to request the exception of the project in the election ban to award the contract immediately once the BAC issued its award recommendation through a resolution.

## 5. Notice to the Bidders

Through this Bid Bulletin, the BAC would like to inform the bidders that the cost of administrative cost is hereby reduced from 4% to 1%. The submission and opening of bids are moved to March 17, 2025.
