This Supplemental Bid Bulletin No. 1 dated March 19, 2025 is being issued to clarify, modify or amend items in the Bidding Documents.

The following items in the Bidding Documents for the Supply and Delivery of Four Hundred Fifty (450) units of Wooden Classroom Chairs as discussed and agreed during the pre-bid conference held last March 14, 2025 are hereby revised/amended:

4. Other Discussions:

- a. The Bidding Documents was presented and discussed during the meeting. Bidders are made to understand the documents they need to submit as discussed in provided checklist. Bidders are reminded to sign all pages of the triplicate copies and requested to bring one flashdrive containing the e-copies of their submitted eligibility, technical and financial requirements. The BAC secretariat added that Section VI (Schedule of Requirements) and Section VII. (Technical Specifications) of the Bidding Documents must be signed by the bidder's authorized representative and both must be included in the first envelope during the bid submission.
- b. The required number of years for the bidders' SLCC was changed from to two
 (2) to five (5) years.



- c. One of the bidders requested to have a tolerance or size range limits of the woods. The BAC replied that the bidders should strictly follow the specified size stipulated in the Bidding Documents to be compliant particularly during the actual inspection where the COA is invited.
- d. Another bidder requested to allow the bidders to offer alternative types of woods such as mahogany or lauan wood other than gmelina. The BAC decided that only gmelina wood is required for the project.
- e. One of the bidders inquired whether the BAC will the accept contract that engaged in making wood signages for their SLCC. The BAC answered that the project requires SLCC that specifically engaged in supplying home or office furniture.

This Supplemental Bid Bulletin No. 1 shall form part of the Bid Documents. Any provision in the Bid Documents inconsistent herewith is hereby amended, modified, and superseded accordingly.
